Re: Supplemental Letter Requesting Investigation of Nominating Petition of U.S. Senate Candidate Mike Rogers for Potential Fraud

Dear Members of the Board of State Canvassers:

I. <u>Introduction</u>

On behalf of Michigan voter Emily Judd, the Michigan Democratic Party (MDP), and DSCC aka Democratic Senatorial Campaign Committee, we write to supplement our May 17, 2024 letter with additional indications of potential fraud in the nominating petition of Republican U.S. Senate Candidate Mike Rogers. As discussed herein and in the attached exhibits, our investigation has thus far uncovered indicia of potential fraud associated with the petition sheets of at least 18 circulators, who together submitted approximately 12,293 signatures in support of Mr. Rogers' nomination. As the Board has previously determined, fraud on any one sheet submitted by a particular circulator necessarily calls into question the validity of all of that circulator's sheets. If the Board finds that any circulator submitted a fraudulent petition sheet, it should invalidate all of that circulator's sheets—for any candidate, in addition to any signatures across the petition that are found to be invalid for other reasons.¹

Candidate Rogers announced in November 2023 that he had collected 30,000 petition signatures to qualify for the ballot.² Nevertheless, he waited until April 22, 2024, the day before the deadline, to file his petition. That means Mr. Rogers had five full months to review and confirm the validity of the petition sheets collected by his campaign, and it appears he failed to do so.

II. Discussion

Since we submitted our May 17 letter, we have obtained declarations from 6 voters who affirmed that, although their names, information, and purported signatures appear on petition sheets for Mr. Rogers, they did not fill out or sign those petition sheets. One such declaration is from Mary Alexander, who also confirmed that her brother DeWayne Washington could not possibly have signed the same petition sheet where her name appears because, at the time he purportedly signed, he was deceased. See Exhibit 1; see also Exhibits 2-6. Thirteen other voters have executed declarations affirming that they do not have any recollection of ever signing the petition and would not knowingly have signed a petition to support Mr. Rogers. See Exhibits 7-19. All of these declarations were collected only during the last several days.

A complete list of the circulators for whom a voter has affirmed via declaration that they did not sign a petition—despite their name appearing on the circulator's petition—and the total number of signatures that each such circulator submitted in support of Mr. Rogers is provided below. As reflected by this list, the circulators who submitted petition signatures that have been called into question by these declarations were prolific circulators for Mr. Rogers.

Second, many circulators who collected signatures for Mr. Rogers also submitted petition sheets with errors and markers that this Board has found to be indicative of fraud in the past, such as address errors, misspelled names, and inconsistent handwriting across petition sheets.³ For example:



• Sheet 807, submitted by Zachary Hamilton, demonstrates evidence of incomplete "roundtabling" similar to evidence the Board has cited in the past as potentially indicative of fraud. Unlike prior examples, where individuals in "roundtabling" left entire lines in the middle of a petition page blank, here it appears that the individuals filling out this sheet may have been assigned specific signature fields to fill out, and in some cases failed to complete those fields. For example, on line 7, the signature and zip code are filled out, and the rest of the fields in that line appear to have been "skipped." On line 9, only the signature, name, and date were filled out, and the rest of the fields appear to have been "skipped." Although it is not uncommon for a voter to change their mind in the middle of completing a line and cross it out, the pattern of blank fields shown on this sheet is suspicious.

Third, many of the petition sheets submitted by circulators for Mr. Rogers reveal other suspicious patterns that warrant investigation. For example, at least one of Mr. Rogers' circulators, Dennis Rodzik, submitted petition sheets containing significant numbers of signatures from voters who listed addresses in geographically disparate parts of the state—often on opposite sides of Michigan, many hours apart—all purportedly collected on the same day. See Exhibit 21.

Dennis Rodzik collected 84 signatures from ten different counties across Michigan on one day, October 14, 2023:

In total, Mr. Rodzik submitted 1,882 signatures for Mr. Rogers.

Those signatures should all be investigated. According to Donald Michael Kolehouse II, founder of canvassing firm Kolehouse Strategies, collecting such a high volume of signatures over such a widespread geographic distribution that includes multiple low-population counties is extremely atypical and warrants further investigation from the Board. See Exhibit 20.

Finally, as discussed in our May 17 letter, ten circulators who were named in the complaints alleging fraud in Lisa Neilson's and Matthew Ackerman's petitions to qualify as candidates for the Court of Appeals also circulated petition sheets for Mr. Rogers. To the extent the Board finds that these circulators submitted fraudulent petition sheets for candidates Neilson and Ackerman, it should also investigate the sheets they submitted for Mr. Rogers. Those circulators, and the number of signatures they submitted for Mr. Rogers, are listed below.

In addition to indicators of potential fraud, our review of the state's sample of Mr. Rogers' petition sheets revealed that as many as 23% of the signatures on the petition were provided by individuals not registered to vote in Michigan. Because the sample is representative of the

full petition, we presume the Board's review will find a similar percentage of unregistered voters in the full universe of Mr. Rogers' petition sheets.

III. Conclusion

In total, Mike Rogers submitted 29,985 signatures. Our review of the Board's sample of Mr. Roger's signature lines revealed that as many as 23% of the individuals who signed Mr. Rogers' petition are not registered to vote and therefore not qualified to sign. If that same percentage holds across the entire petition, then approximately 6,500 of the signatures on Mr. Rogers' petition are invalid on that basis. In addition, there is reason for the Board to investigate the signatures collected by the following circulators based on the information provided in this letter and our May 17, 2024 letter:⁴

Even assuming that 23% of the individuals who signed these circulators' pages are among those not registered to vote, that leaves approximately **9,465 signatures** implicated by the indications of potential fraud discussed in this letter and our May 17 letter. Combined with the approximately 6,500 signers we anticipate the Board will find to be unregistered, **15,965 signatures on Mr. Rogers' petition may be implicated.**

Given the total number of signatures that are potentially implicated and may be invalid, **we urge the Board to open a prompt investigation.**

If the Board finds that Mr. Rogers or any other candidate did not submit at least 15,000 valid signatures, then those candidates should not be qualified for the ballot.



for over twenty candidates over the course of my career.

5. Based on my experience, I have developed expertise in signature collection tactics and am very

familiar with signature collection patterns and practices in Michigan.

6. I have reviewed some of candidate Mike Rogers's petition sheets, including several that were

circulated by Dennis Rodzik.

7. Mr. Rodzik appears to have collected signatures over the course of a single day from voters who

listed addresses in multiple low-population counties that are several hours away from each other.

8. Based on my experience and expertise, I believe that Mr. Rodzik's petition sheets—and others

that may exhibit similar patterns—warrant further investigation by the Board because the

geographic distribution and volume of signatures he purports to have collected on single days is

extremely atypical.



Exhibit 21: Geographic Distribution of Mr. Rodzik's Petition Signatures




